PROFILE

Karthik S is a theatre artist based in Bangalore, whose work spans writing, directing, performing, and teaching. A graduate of the National School of Drama (Bengaluru Centre, 2019) and the Intercultural Theatre Institute (ITI), Singapore (2024), he has been awarded scholarships by the Government of Karnataka and the Tan Chay Bing Foundation for excellence in performance and theatre practice.

At ITI, Karthik underwent intensive training in classical and traditional performance forms such as Noh (Japan), Kutiyattam (India), Wayang Wong (Indonesia), and Beijing Opera (China), complemented by Western acting methodologies and contemporary movement practices. His artistic approach is rooted in reimagining traditional, folk, and ritualistic forms from India and Asia through a contemporary lens—creating immersive, inventive performance languages grounded in devised theatre.

Karthik's recent works include *It's Your Fault*, a movement-based devised play examining gender and violence in India through the physical vocabulary of Kalaripayattu, and *The Bath of Love*, a solo performance blending puppetry, physical theatre, and ritual. He is currently developing a new puppetry production exploring collective storytelling and the shifting boundaries between performer and object.

DECLARATION & ELIGIBILITY :

- 1.) **I confirm that I am an adult (aged 18 years or above)** with full legal capacity to execute this application.
- 2.) **I have read and fully understand this form in English**, or it has been explained to me in a language I comprehend, including all terms, conditions, and legal implications.
- 3.) All information provided for admission to **RANGASOURABHA Trust** paid acting classes is true, correct, and complete.
- 4.) I am of sound mind and signing voluntarily without duress or coercion. I have no medical conditions, physical disabilities, allergies, or psychological conditions that would prevent me from safely participating in acting classes, or I have disclosed such conditions in writing to the Trust.

CONSENT FOR DATA PROCESSING :

- 5.) I give **free, specific, informed consent** to Rangasourabha Trust to collect, process, store, and retain my personal data including application details, contact information, photographs, video recordings, and last 4 digits of my Aadhaar Number for the following specific purposes: enrolment processing, communication regarding classes, fee management, attendance tracking, regulatory compliance, and institutional record-keeping. **This consent shall remain valid and effective for the entire duration of my association with the Trust and thereafter for such period as required for institutional archival purposes and legal compliance and audit requirements.** I consent to my personal data being shared with payment processors and banks for fee collection purposes, government authorities if required by law or legal process, emergency services in case of health or safety incidents, and auditors and legal advisors for compliance purposes.

I acknowledge that classes, performances, and events may be covered by media outlets, journalists, or attendees who may photograph or record independently, and the Trust is not responsible for such third-party media usage.

TERMS & CONDITIONS :

8.) I agree to maintain **regular and punctual attendance** in all scheduled classes, rehearsals, and activities. Minimum attendance as specified by the Trust may be required for certification/completion. Frequent absenteeism may result in loss of learning continuity and affect performance evaluation. Absence from three or more consecutive classes without prior intimation may result in administrative review and potential enrolment suspension. In case of absence due to illness, emergency, or unavoidable circumstances, I will inform the Trust in advance (or as soon as reasonably possible), and medical certificates may be required for prolonged absence. The Trust is not obligated to provide make-up classes or refunds for missed classes. I agree to arrive on time for all classes and activities, as late arrival disrupts the learning environment and shows disrespect to instructors and fellow students. Persistent lateness may result in disciplinary action. I understand that course duration, curriculum, and teaching methodology are at the sole discretion of the Trust, which may modify course content, replace instructors, or introduce new modules as deemed necessary for educational improvement. The Trust does not guarantee specific learning outcomes, performance abilities, or career placements.

9.) I agree to conduct myself in a respectful, professional, and ethical manner at all times, treating instructors, staff, fellow students, and visitors with courtesy and respect, and not engaging in harassment, bullying, discrimination, hate speech, or offensive behaviour based on race, religion, caste, gender, sexual orientation, disability, or any other protected characteristic. I will respect diverse opinions, maintain a positive learning environment, and address grievances through proper channels rather than confrontational behaviour. I will adhere to the dress code specified by the Trust for classes (typically comfortable, movement-friendly attire appropriate for physical activity), with specific requirements communicated during orientation. I agree to follow all safety guidelines including fire safety and emergency evacuation procedures, COVID-19 or other health protocols (if applicable), equipment handling and stage safety rules, and prohibition of weapons or dangerous items on premises. The following are strictly prohibited and may result in immediate termination: consumption of alcohol, tobacco, or recreational drugs on Trust premises or attending classes under their influence, possession or use of illegal substances, theft, damage to property or vandalism, physical violence, threats or intimidation, sexual harassment or inappropriate behaviour, unauthorized recording or photography during classes (except with explicit permission), cheating, plagiarism or academic dishonesty, and bringing disrepute to the Trust through social media posts, public statements, or actions. I will use Trust premises, equipment, and materials responsibly, report any damage or safety hazards immediately, not use facilities for unauthorized commercial purposes or personal gain, and leave premises clean and organized after use. Violation of these conduct rules may result in verbal or written warning, temporary suspension from classes, monetary fines or compensation for damages, permanent expulsion from the program without refund, or legal action if criminal offences are involved. The Trust's decision on disciplinary matters shall be final and binding.

10.) **I am in good health and capable of participating in acting classes. I acknowledge that acting classes may involve physical and mental activity and performance-related exertion, and I voluntarily participate at my own risk and responsibility.** Acting classes involve inherent risks of injury including sprains, strains, bruises, falls, collisions, vocal strain, and emotional/ psychological stress. Despite safety measures, accidents and injuries may occur. I have been advised to obtain appropriate personal accident insurance and health insurance coverage. In the event of a medical emergency where I am unable to provide consent, I authorize the Trust to arrange for emergency medical treatment, ambulance services, or hospitalization as deemed necessary, authorize qualified medical professionals to provide necessary treatment, understand that the Trust will make reasonable efforts to contact my emergency contact person, and I will be responsible for all medical expenses incurred. The Trust, its trustees, employees, volunteers, instructors, agents, and representatives shall not be held liable for any injuries, accidents, illnesses, health complications, aggravation of pre-existing medical conditions, or psychological/emotional distress arising from performance anxiety, feedback, or peer interactions sustained during classes, rehearsals, performances, or related activities.

12.) **Intellectual Property:** All teaching materials, training manuals, scripts, screenplays, scene texts, choreography notes, performance techniques, methodologies, curricula, handouts, course content, original theatrical productions, plays, performances, and creative works are the exclusive **intellectual property** of Rangasourabha Trust or its licensors, protected by copyright. I shall not reproduce, copy, photocopy, scan, digitally record, distribute, share, upload, transmit, publicly perform, adapt, create derivative works from, or use any teaching materials for commercial purposes, paid workshops, teaching others, or claim authorship/ownership without prior written permission. Audio or video recording of classes is generally prohibited unless expressly permitted by the instructor for specific educational purposes; if permitted, recordings are for personal study only and must not be shared or published. Any performances, scenes, monologues, or creative work developed by me during the course may be recorded and archived by the Trust for internal documentation and used for promotional purposes as per the media consent above but remain my intellectual property only if entirely original and not based on Trust-provided materials. Unauthorized use, reproduction, or commercial exploitation may result in immediate termination of enrolment without refund, legal action for copyright infringement, and claims for damages and losses.

The Trust makes no representations, warranties, or guarantees regarding my improvement in acting skills or artistic abilities, career opportunities, auditions, casting, employment in the entertainment industry, networking opportunities or industry connections, or selection for performances or showcases. Acting is a highly competitive field with uncertain outcomes, and success depends on multiple factors including talent, effort, opportunities, and market conditions beyond the Trust's control.

INDEMNIFICATION :

14.) I hereby **irrevocably and unconditionally agree to indemnify, defend, protect, and hold harmless** Rangasourabha Trust, its trustees, employees, volunteers, instructors, agents, representatives, and successors from all claims, demands, actions, suits, allegations, damages, losses, liabilities, costs, and expenses (including legal fees and court costs) arising from my participation in acting classes and use of Trust premises, any violation of these terms and conditions, my conduct toward instructors, fellow students, or third parties, any accidents, injuries, health complications, or loss of life, any third-party claims or legal actions, any dispute related to my personal data or Aadhaar details, and copyright or intellectual property infringement.
